ADMISSION NOTICE FOR DIRECT SECOND YEAR OF DIPLOMA COURSES IN ENGINEERING AND TECHNOLOGY FOR ACADEMIC YEAR 2021-22

In accordance with the Maharashtra Government Extraordinary Notification No.232 published on 05/07/2018, Government of Maharashtra vide Government Resolution Higher and Technical Education Department No. Sankirn-2019/(C.R.06/19)TE-5 dated 06/02/2019, Director, Technical Education is the Competent Authority for implementation of all the activities related to admission of Diploma Courses under the purview of Directorate of Technical Education, Maharashtra State.

This Notice is being issued for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation for admissions to Direct Second Year Of Full Time Diploma Engineering and Technology programs in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2021-22 in the State of Maharashtra.

However, considering the COVID-19 outbreak, it is essential to maintain the social distancing and avoid the crowding of parents and students at the designated Facilitation Centers(FC).

In view of this, the concept of e-Scrutiny in addition to the Physical Scrutiny of the documents is made available by the Competent Authority. The candidate shall select the mode of scrutiny depending upon his/her convenience for online filling & confirming the application form.

- **Method 1:-** The Candidate shall register online and select the e- Scrutiny Mode. The candidate shall fill & submit online application form and upload the required documents from anywhere through the computer/smartphone connected to internet and he/she need not have to visit personally for verification and confirmation of the application form. His/Her application & documents shall be verified and confirmed by the designated Facilitation Center through e-Scrutiny Mode.
- Method 2:- The Candidate shall register online through mobile (Smart phone) or computer and select the Physical Scrutiny Mode. The candidate who does not have any mobile (Smart phone) or computer facility for registration shall visit the nearest FC for registration & scheduling. The registered candidates shall book convenient slot [date & timing] of FC. The candidate need to fill online application form, scan & upload required documents by themselves free of cost at FC. Candidate shall visit FC as per schedule and do the verification and confirmation of application form free of cost at FC by maintaining social distancing norms.

Aspiring candidates are informed to read the Rules, process and instructions given in the Information Brochure carefully. The Information brochure is published on https://dsd21.dtemaharashtra.gov.in for download.

Eligibility Criteria for Admission Maharashtra State/All India Candidates

- (i) The Candidate should be an Indian National
- (ii) Passed 10+2 examination with Physics/ Mathematics / Chemistry /Computer Science/Electronics /Information Technology/ Biology/ Informatics Practices/Biotechnology/ Technical Vocational subject */ Agriculture/ Engineering Graphics/ Business Studies/ Entrepreneurship (Any of the three)

OR

10th + (2 years ITI) with appropriate Trade

* List of Technical Vocational subject is given in Annexure-IIIA of Information Brochure 2021-22, published by the Directorate.

Important Note:

- 1. Candidates who have registered with Maharashtra State Board 12th std/HSC examination for April-May 2021 shall fill their Examination Seat Number in Educational Qualification Details and complete the forms by paying the fees. (Candidate shall obtain Examination Seat Number from their respective college.)
- **2.** Marks obtained by the candidate in April-May 2021 Maharashtra State Board 12th std/HSC examination will be fetched from the result data received from Maharashtra State Board of Secondary & Higher Secondary Education (MSBSHSE) and it will be updated in the application form of the Candidate.
- **3.** After declaration of the result of 12th std/HSC examination by Maharashtra State Board of Secondary & Higher Secondary Education (MSBSHSE) candidate shall verify the correctness of mark/s in his/her application form and in case of discrepancies of the mark/s candidate shall raise grievances through either e-Scrutiny Mode or Physical Scrutiny Mode. Mark/s shall be modified if the grievance raised is justified and found correct.
- **4.** Candidate registered for Class 12, April-May 2021 examination from CBSE and ICSE board shall fill their Educational Qualification Details after declaration of the result from respective board and complete application form.
- **5.** Candidate Passed 12th std/HSC examination prior to 2021 shall fill & complete the application form with all qualification details and upload relevant document by paying the fees.
- **6.** Eligibility of the Student for the specific branches of Diploma Programs shall be as per MSBTE guidelines prescribed in information brochure for 2021-22.
- 7. Other than Maharashtra State Candidates shall be eligible for Institution quota only. (There is No Institutional quota as such for direct second year diploma admissions; however vacancies if any after last round can be filled by institution, which is termed as institution quota.)

Online Registration for Admission: -

- 1. The candidates should apply online on https://dsd21.dtemaharashtra.gov.in as per schedule.
- Candidates are required to pay application fee as given below only by online mode through Credit Card/ Debit Card/ UPI/ Net Banking (No other mode of payment shall be permitted). Application fee paid is non-refundable.

	 Such candidate shall fill online application form and upload the required documents from any computer/smartphone connected to internet from anywhere. 		
	2. Such candidate need not have to visit to FC for verification and confirmation of the application form. His/Her application & documents shall be verified and confirmed by the FC through e-Scrutiny Mode.		
	 Juring e-Scrutiny of Application Form of such candidate: If no error is found: the status of verification & confirmation of the application form shall be available in candidates Login along with receipt cum Acknowledgement. If error is found: the details of errors shall be intimated to candidates by reverting back his/her Application for its rectification through candidates Login. Candidate shall edit the reverted Application form and resubmit the application for e-Scrutiny through his/her login. 		

Such candidate shall visit the facilitation Center online selected by himself/herself, along with the required documents as per the allotted time slot for online filling, scanning & uploading of required documents, verification and confirmation of application form. After verification & Confirmation of application form, FC shall issue the receipt cum Acknowledgement. The status of Confirmation shall be available in candidates Login along with receipt cum Acknowledgement.

*Facility of Online Registration & Documents verification, confirmation of Application Form for Admission to Seats other than CAP Seats shall be continued till the Cut off date of admission. Applications registered, verified & confirmed through e-Scrutiny Mode or Physical Scrutiny Mode after Last Date i.e. 04-08-2021 shall be considered only for Institute Level/Against CAP Seats.

Important Note: -

- **1. All types of candidates** aspiring for admission under CAP seats shall register, get Documents Verified & Application Form confirmed either by <u>E-Scrutiny Mode or Physical Scrutiny Mode</u>. Such eligible registered candidates shall be considered for CAP Merit and admission through CAP.
- **2.** The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is **mandatory** to get registered, documents verified and confirmation of application either by <u>E-Scrutiny Mode or Physical Scrutiny Mode</u>. Such candidates must apply separately to Institutes for admissions. Merit of such candidates shall be prepared by the Institute at the institute level.

Important Instructions for candidates:

- 1. The Candidates opting Physical Scrutiny Mode shall strictly follow the guidelines related to COVID-19 outbreak issued by the Government of Maharashtra from time to time. It is essential to maintain the social distancing and avoid the crowding of the aspiring candidates and parents at the designated Facilitation Centers.
- 2. If candidates fail to confirm online filled application form as per the mode selected either by <u>E-Scrutiny Mode or Physical Scrutiny Mode</u>, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Non-CAP process.

- 3. All Backward Class candidates (for VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC Category) shall produce Non Creamy Layer certificate valid up to 31st March 2022 as per the mode selected either by <u>E-Scrutiny Mode or Physical Scrutiny Mode</u>. If these candidates are not able to produce the Non Creamy Layer certificate, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats under the admission process.
- 4. Economically Weaker Section (EWS) Candidate shall produce Eligibility Certificate for Economically Weaker Section valid up to 31 March 2022 as per the mode selected either by E-Scrutiny Mode or Physical Scrutiny Mode. If these candidates are not able to produce the Eligibility Certificate for Economically Weaker Section, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats under the admission process.
- 5. During <u>E-Scrutiny Mode or Physical Scrutiny Mode</u>, Candidate shall produce the relevant & valid documents to substantiate the claim made in the application form. In case of non submission of the relevant documents, the candidate shall lose such claims made in the application and applications of such candidates shall be confirmed without considering such claims.
- 6. Candidates who have registered as a reserved category candidate but unable to produce required certificate for reservation claim during documents verification stage either by E-Scrutiny Mode or Physical Scrutiny Mode shall be treated as GENERAL category candidates and have to pay difference of fee of ₹100/through online mode only.
- Candidates opting for Physical Scrutiny Mode shall carry all required documents in original for scrutiny at FC.
- 8. The further schedule for Filling & Confirmation of Option Form for CAP Rounds, CAP Allotment, Acceptance of seat, reporting to Institutes by candidates, cut off date of admission etc. shall be declared after declaration of the Final Merit List and shall be published on website: https://dsd21.dtemaharashtra.gov.in

General Notes:

- Candidate who have opted <u>Physical Scrutiny Mode</u> can avail the IT facility which is available at Facilitation Centre (FC) free of cost for submission, scanning and uploading documents, and confirmation of Application form The candidate shall adhere to the COVID-19 guidelines issued by the GoM time to time during reporting at the FC.
- 2. For <u>Physical Scrutiny Mode:</u> List of FC's is available on website and these FC's shall remain open during the schedule between 10.00 a.m. to 6.00 p.m.
- 3. Eligibility, Rules & regulations for admission shall be made available on the website.
- 4. The schedule displayed above is provisional and may change under unavoidable circumstances. The revised schedule, if any, will be notified on website https://dsd21.dtemaharashtra.gov.in Please visit the website or contact the concerned office of the Joint Director of Technical Education, Regional Offices for further details.
