Including Admission for Separate Division of Direct Second Year of Diploma Courses For Working Professionals)

In accordance with the Maharashtra Government Extraordinary Notification No.232 published on 05/07/2018, Government of Maharashtra vide Government Resolution Higher and Technical Education Department No. Sankirn-2019/(C.R.06/19)TE-5 dated 06/02/2019, Director, Technical Education is the Competent Authority for implementation of all the activities related to admission of Diploma Courses under the purview of Directorate of Technical Education, Maharashtra State.

This Notice is being issued for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation for admissions to Direct Second Year Of Full Time Diploma Engineering and Technology programs in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2025-26 in the State of Maharashtra. This Includes Admission for Separate Division of Direct Second Year of Diploma Courses For Working Professionals.

The concept of e-Scrutiny in addition to the Physical Scrutiny of the documents is made available by the Competent Authority. The candidate shall select the mode of scrutiny depending upon his/her convenience for online filling & confirming the application form.

- **Method 1:-** The Candidate shall register online and select the e- Scrutiny Mode. The candidate shall fill & submit online application form and upload the required documents from anywhere through the computer/smartphone connected to internet and he/she need not have to visit personally for verification and confirmation of the application form. His/Her application & documents shall be verified and confirmed by the designated Facilitation Center through e-Scrutiny Mode.
- **Method 2:-** The Candidate shall register online through mobile (Smart phone) or computer and select the Physical Scrutiny Mode. The candidate who does not have any mobile (Smart phone) or computer facility for registration shall visit the nearest FC for registration & scheduling. The registered candidates shall book convenient slot [date & timing] of FC. The candidate need to fill online application form, scan & upload required documents by themselves free of cost at FC. Candidate shall visit FC as per schedule and do the verification and confirmation of application form free of cost at FC.

Aspiring candidates are informed to read the Rules, process and instructions given in the Information Brochure carefully. The Information brochure is published on **https://dsd25.dtemaharashtra.gov.in/** for download.

# Important Note:

- **1.** Candidates who have registered with Maharashtra State Board 12<sup>th</sup> std/HSC examination for Feb-March 2025 shall fill their Examination Seat Number in Educational Qualification Details & also fill the necessary information and complete the forms by paying the fees.
- 2. Marks obtained by the candidate in Feb-March 2025 Maharashtra State Board 12<sup>th</sup> std/HSC examination will be fetched from the result data received from Maharashtra State Board of Secondary & Higher Secondary Education (MSBSHSE) and it will be updated in the application form of the Candidate.
- **3.** Candidate registered for Class 12, Feb-March 2025 examination from CBSE and ICSE board shall fill their Educational Qualification Details as per declaration of the result from respective board and complete application form.
- **4.** Candidate Passed 12<sup>th</sup> std/HSC examination prior to 2025 shall fill & complete the application form with all qualification details and upload relevant document by paying the fees.
- **5.** Other than Maharashtra State Candidates shall be eligible for Institution quota only. There is No Institutional quota as such for direct second year diploma admissions except Separate Division of Direct Second Year of Diploma Courses For Working Professionals. However, Vacancies, if any, after last CAP Round, can be filled, from amongst the Maharashtra State candidates and Other than Maharashtra State Candidates.
- **6.** In case the result of the candidate is given in terms of grades, such candidates are required to submit the graded result into the equivalent marks authorized from the concerned Institute /Board. The eligibility shall be decided on the basis of equivalent marks.

### Online Registration for Admission: -

- The candidates should apply online on https://dsd25.dtemaharashtra.gov.in/ as per the schedule. Candidates applying for admission under Separate Division of Direct Second Year of Diploma Courses For Working Professionals shall apply online on https://dsdwp25.dtemaharashtra.gov.in/ as per the schedule. Candidate can also fill, submit and confirm their application by downloading App on mobile "DTE Diploma Admission" available on Android/IOS Store.
- Candidates are required to pay application fee as given below only by online mode through Credit Card/ Debit Card/ UPI/ Net Banking (No other mode of payment shall be permitted). Application fee paid is nonrefundable.

# Important Note: -

- **1. All types of candidates** aspiring for admission under CAP seats shall register, get Documents Verified & Application Form confirmed either by E-Scrutiny Mode or Physical Scrutiny Mode. Such eligible registered candidates shall be considered for CAP Merit and admission through CAP.
- 2. The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is **mandatory** to get registered, documents verified and confirmation of application either by E-Scrutiny Mode or Physical Scrutiny Mode. Such candidates must apply separately to Institutes for admissions. Merit of such candidates shall be prepared by the Institute at the institute level.
- 3. For Working Professionals: Candidates desirous to take admission in separate division for Working professionals of Direct Second Year Diploma in Engineering and Technology shall read carefully the Rules published in clause C(4) "Allocation of Seats for Working Professionals (Supernumerary Division)" under Schedule –III of the Information Brochure.

#### **Important Instructions for candidates:**

- 1. If candidates fail to confirm online filled application form as per the mode selected either by E-Scrutiny Mode or Physical Scrutiny Mode, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Non-CAP process.
- 2. All Backward Class candidates (for VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC, SEBC Category) shall produce Non Creamy Layer certificate valid up to 31<sup>st</sup> March 2026 as per the mode selected either by E-Scrutiny Mode or Physical Scrutiny Mode. If these candidates are not able to produce the Non Creamy Layer certificate, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats under the admission process.
- 3. Economically Weaker Section (EWS) Candidate shall produce Eligibility Certificate (See Pro forma V) for Economically Weaker Section valid up to 31<sup>st</sup> March 2026 / Valid for Year 2025-26, as per the mode selected either by E-Scrutiny Mode or Physical Scrutiny Mode. If these candidates are not able to produce the Eligibility Certificate for Economically Weaker Section, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats under the admission process. [In any case the EWS certificate issued as per the Central Government EWS reservations policy (Central List) shall not be accepted.]
- 4. During E-Scrutiny Mode or Physical Scrutiny Mode, Candidate shall produce the relevant & valid documents to substantiate the claim made in the application form. In case of non submission of the relevant documents, the candidate shall lose such claims made in the application and applications of such candidates shall be confirmed without considering such claims.
- 5. Candidates who have registered as a reserved category candidate but unable to produce required certificate for reservation claim during documents verification stage either by E-Scrutiny Mode or Physical Scrutiny Mode shall be treated as GENERAL category candidates and have to pay difference of fee of ₹100/-through online mode only.
- 6. Candidates opting for Physical Scrutiny Mode shall carry all required documents in original for scrutiny at FC.
- 7. The further schedule for Filling & Confirmation of Option Form for CAP Rounds, CAP Allotment, Acceptance of seat, reporting to Institutes by candidates, cut off date of admission etc. shall be declared after declaration of the Final Merit List and shall be published on website: https://dsd25.dtemaharashtra.gov.in/

#### General Notes:

- 1. Candidate who have opted Physical Scrutiny Mode can avail the IT facility which is available at Facilitation Centre (FC) free of cost for submission, scanning and uploading documents, and confirmation of Application form.
- 2. For Physical Scrutiny Mode: List of FC's is available on website and these FC's shall remain open during the schedule between 10.00 a.m. to 6.00 p.m.
- 3. Eligibility, Rules & regulations for admission shall be made available on the website.
